### 16. Cancellations:

### 17. Changes:

Changes in players' entries are accepted till the cancellation deadline. After that time, no changes on players' entries nor in team compositions are accepted. If cancellations occurs from that time till the time of the draws and are directly notified to the ITTF Competition Manager, the Jury may decide to accept merging the remaining players (i.e. if one player from team "A" and one player of team "B" of the Association XXX cancel their participation **BEFORE** the draw is made but after the Cancellation deadline, the Jury may accept to merge the remaining players of Team "A" and "B" in one team.). The same applies for doubles.

### 18. Visas:

If you need a visa, please contact the Organizing Committee as soon as possible, so we can assist you with the visa process.

### 19. Racket Controls:

If racket control includes official test for VOC, miniRAE device will be used according to the ITTF decision.  
In this case, players will be invited to voluntary tests before competition starts. The ITTF Equipment Committee strongly recommends all players to make certain that new coverings are aired 72 hours before use
